
Monthly Comment

INTO 2024 – What a year. The PARITON Fund gained roughly 13% driven by both equities and Bonds but also the admixtures from synthetic return and convexity attributed positively. To keep a long lookback short: Equity markets have been dominated for a while by the AI frenzy, but later found back to the "all about yields"-story, where the direction of Bonds determined the direction of equites. The year ended with a big dovish shift by central banks which triggered the sharpest 2-month rally in equities in almost 20 years and the biggest 2-months gain for global bonds on record. That 's it and it seems there is not much room left for 2024 as the market expects 6 rate cuts for both ECB and FED. So we can reasonably await for the coming year more "all about yields" summaries and while rates might have peaked the big debt peak will probably have big influence on markets directions.




Fund description

The Tungsten PARITON UI strategy aims to achieve a stable absolute return by combining several different asset classes in a multi asset portfolio.

The Tungsten PARITON UI fund considers only those assets that deliver an attractive risk/return ratio. To avoid a one-sided allocation, weights to these assets are assigned using a special risk balancing method. The employment of such risk balancing promises high risk-adjusted returns (Sharpe ratios) as the aggregate portfolio risk is managed very effectively. Due to the low risk nature of certain asset classes the fund may employ leverage in order to achieve a relatively constant level of volatility. The expected return of the strategy is 3%-6% p.a. above Euribor (1m).


MSCI ESG Rating and Distribution






Quarterly performance attribution²⁾




Correlation since 01/2014 (daily data)¹⁾
